

## HOUSING CANCELLATION REQUEST

If a student wishes to cancel their housing agreement, formal written notice must be provided to the leasing office prior to move out. Cancellation charges will be assessed depending on the date of cancellation and the reason for leaving.

If the student cancels their housing agreement, the student must vacate within 72 hours. Cancellation charges must be paid within 30 days. Students with unpaid housing account balances will be placed on Financial Hold. Students placed on Financial Hold become ineligible for further registration, and transcripts will not be released until the student account is paid in full. A return payment fee of \$50.00 may be assessed when payment is not honored by the bank on which it was drawn. Debtors who do not make satisfactory payment arrangements on their past due accounts may have their accounts placed with a collection agency. It is the policy of the University that unpaid accounts will be assessed the costs and expenses of collection, including attorney fees.
